**Deliveries must be scheduled 72 hours ahead** along with estimated time of delivery to the winery. The weigh scale is open from **6:00 AM to 4:00 PM Monday through Saturday**. If the delivery is late we must get a call ahead and cannot guarantee weigh or processing that day.

The client is responsible for providing pest reporting if needed to Rack & Riddle at the time of scheduling, i.e., EGVM, LBAM. The driver is responsible for carrying appropriate pest paperwork.

**From the South:**

Take 101 Hwy north to Geyserville Ave. exit. Follow Geyserville Ave. north to Hwy 128. Turn right and follow to 4001 Hwy 128.

**From the North:** Take 101 Hwy to Canyon Rd. Take a left at stop. Then a right onto Geyserville Rd. At stop sign make a left onto Hwy 128 and follow to 4001 Hwy 128
